A1. Adjust the 2019 5.5% Revenue Limit to correct the revenue base, if necessary:

A1a. The 2019 Revenue Limit **[\$20,597]** + 2018 Amount Over Limit **[\$0]** = **\$20,597**

A1b. The lesser of Line A1a **[\$20,597]** or the 2019 Certified Gross General Operating Revenue **[\$19,990]**

A1c. Line A1b **[\$19,990]** + 2019 Omitted Revenue, if any **[\$9]**

= A1.

A2. Calculate the 2019 Tax Rate, based on the adjusted tax base:

Adjusted 2019 Revenue Base **[\$19,999]** ÷ 2019 Net Assessed Value **[\$17,504,161]**

= A2.

A3. Total the assessed value of all the 2020 "growth" properties:

Annexation or Inclusion **[\$0]** + New Construction **[\$212,563]** + Increased Production of Producing Mine **[\$0]**¹ + Previously Exempt Federal Property **[\$0]**¹ + New Primary Oil & Gas Production **[\$0]**¹

= A3.

A4. Calculate the revenue that the "growth" properties would have generated in 2019:

Line A3 **[\$212,563]** x Line A2 **[0.001143]**

= A4.

A5. Expand the Revenue Base by "revenue" from "growth" properties:

Line A1 **[\$19,999]** + Line A4 **[\$243]**

= A5.

A6. Increase the Expanded Revenue Base by allowable amounts:

A6a. The greater of 5.5% of Line A5 **[\$1,113]** or \$0 = **\$1,113**

A6b. Line A5 **[\$20,242]** + Line A6a **[\$1,113]** + DLG Approved Revenue Increase **[\$0]** + Voter Approved Revenue Increase **[\$0]**

= A6.

A7. 2020 Revenue Limit:

Line A6 **[\$21,355]** - 2020 Omitted Property Revenue **[\$0]**

= A7.

A8. Adjust 2020 Revenue Limit by amount levied over the limit in 2019:

Line A7 **[\$21,355]** - 2019 Amount Over Limit **[\$0]**

= A8.*

*** THE ALLOWED REVENUE OF A8 DOES NOT TAKE INTO ACCOUNT ANY OTHER LIMITS THAT MAY APPLY TO YOUR PROPERTY TAX REVENUE, SUCH AS STATUTORY MILL LEVY CAPS, VOTER-APPROVED LIMITATIONS, THE TABOR PROPERTY TAX REVENUE LIMIT, OR THE TABOR PROHIBITION AGAINST INCREASING THE MILL LEVY WITHOUT VOTER AUTHORIZATION. THE PROPERTY TAX LIMITATIONS WORKSHEET (FORM DLG-53A) MAY BE USED TO PERFORM SOME OF THESE CALCULATIONS FOR COMPARISON TO THE "5.5%" LIMIT.**

The formula to calculate a Mill Levy is:

$$\text{Mill Levy} = \frac{\text{Revenue}}{\text{Current Year's Net Total Taxable Assessed Valuation}^2} \times 1,000$$

² Use the Net Total Taxable Valuation as provided on line 4 of the final Certification of Valuation from the County Assessor.

³ Rounding the mill levy up may result in revenues exceeding allowed revenue.
