**A1. Adjust the 2020 5.5% Revenue Limit to correct the revenue base, if necessary:**

A1a. The 2020 Revenue Limit **[\$271,585]** + 2019 Amount Over Limit **[\$0]** = **\$271,585**

A1b. The lesser of Line A1a **[\$271,585]** or the 2020 Certified Gross General Operating Revenue **[\$258,358]**

A1c. Line A1b **[\$258,358]** + 2020 Omitted Revenue, if any **[\$0]**

= A1.

**A2. Calculate the 2020 Tax Rate, based on the adjusted tax base:**

Adjusted 2020 Revenue Base **[\$258,358]** ÷ 2020 Net Assessed Value **[\$127,647,308]**

= A2.

**A3. Total the assessed value of all the 2021 "growth" properties:**

Annexation or Inclusion **[\$0]** + New Construction **[\$1,864,779]** + Increased Production of Producing Mine **[\$0]**<sup>1</sup> + Previously Exempt Federal Property **[\$0]**<sup>1</sup> + New Primary Oil & Gas Production **[\$0]**<sup>1</sup>

= A3.

**A4. Calculate the revenue that the "growth" properties would have generated in 2020:**

Line A3 **[\$1,864,779]** x Line A2 **[0.002024]**

= A4.

**A5. Expand the Revenue Base by "revenue" from "growth" properties:**

Line A1 **[\$258,358]** + Line A4 **[\$3,774]**

= A5.

**A6. Increase the Expanded Revenue Base by allowable amounts:**

A6a. The greater of 5.5% of Line A5 **[\$14,417]** or \$0 = **\$14,417**

A6b. Line A5 **[\$262,132]** + Line A6a **[\$14,417]** + DLG Approved Revenue Increase **[\$0]** + Voter Approved Revenue Increase **[\$0]**

= A6.

**A7. 2021 Revenue Limit:**

Line A6 **[\$276,550]** - 2021 Omitted Property Revenue **[\$0]**

= A7.

**A8. Adjust 2021 Revenue Limit by amount levied over the limit in 2020:**

Line A7 **[\$276,550]** - 2020 Amount Over Limit **[\$0]**

= A8.\*

\* THE ALLOWED REVENUE OF A8 DOES NOT TAKE INTO ACCOUNT ANY OTHER LIMITS THAT MAY APPLY TO YOUR PROPERTY TAX REVENUE, SUCH AS STATUTORY MILL LEVY CAPS, VOTER-APPROVED LIMITATIONS, THE TABOR PROPERTY TAX REVENUE LIMIT, OR THE TABOR PROHIBITION AGAINST INCREASING THE MILL LEVY WITHOUT VOTER AUTHORIZATION. THE PROPERTY TAX LIMITATIONS WORKSHEET (FORM DLG-53A) MAY BE USED TO PERFORM SOME OF THESE CALCULATIONS FOR COMPARISON TO THE "5.5%" LIMIT.

**The formula to calculate a Mill Levy is:**

$$\text{Mill Levy} = \frac{\text{Revenue}}{\text{Current Year's Net Total Taxable Assessed Valuation}^2} \times 1,000$$

<sup>2</sup> Use the Net Total Taxable Valuation as provided on line 4 of the final Certification of Valuation from the County Assessor.

<sup>3</sup> Rounding the mill levy up may result in revenues exceeding allowed revenue.
