**A1. Adjust the 2021 5.5% Revenue Limit to correct the revenue base, if necessary:**

A1a. The 2021 Revenue Limit **[\$281,291,060]** + 2020 Amount Over Limit **[\$0]** = **\$281,291,060**

A1b. The lesser of Line A1a **[\$281,291,060]** or the 2021 Certified Gross General Operating Revenue **[\$180,410,225]**

A1c. Line A1b **[\$180,410,225]** + 2021 Omitted Revenue, if any **[\$22,808]**

= A1. **\$180,433,033**

**A2. Calculate the 2021 Tax Rate, based on the adjusted tax base:**

Adjusted 2021 Revenue Base **[\$180,433,033]** ÷ 2021 Net Assessed Value **[\$11,582,577,389]**

= A2. **0.015578**

**A3. Total the assessed value of all the 2022 "growth" properties:**

Annexation or Inclusion **[\$0]** + New Construction **[\$96,447,762]** + Increased Production of Producing Mine **[\$0]**<sup>1</sup> + Previously Exempt Federal Property **[\$0]**<sup>1</sup> + New Primary Oil & Gas Production **[\$0]**<sup>1</sup>

= A3. **\$96,447,762**

**A4. Calculate the revenue that the "growth" properties would have generated in 2021:**

Line A3 **[\$96,447,762]** x Line A2 **[0.015578]**

= A4. **\$1,502,463**

**A5. Expand the Revenue Base by "revenue" from "growth" properties:**

Line A1 **[\$180,433,033]** + Line A4 **[\$1,502,463]**

= A5. **\$181,935,496**

**A6. Increase the Expanded Revenue Base by allowable amounts:**

A6a. The greater of 5.5% of Line A5 **[\$10,006,452]** or \$0 = **\$10,006,452**

A6b. Line A5 **[\$181,935,496]** + Line A6a **[\$10,006,452]** + DLG Approved Revenue Increase **[\$0]** + Voter Approved Revenue Increase **[\$0]**

= A6. **\$191,941,949**

**A7. 2022 Revenue Limit:**

Line A6 **[\$191,941,949]** - 2022 Omitted Property Revenue **[\$57,662]**

= A7. **\$191,884,287**

**A8. Adjust 2022 Revenue Limit by amount levied over the limit in 2021:**

Line A7 **[\$191,884,287]** - 2021 Amount Over Limit **[\$0]**

= A8.\* **\$191,884,287**

\* THE ALLOWED REVENUE OF A8 DOES NOT TAKE INTO ACCOUNT ANY OTHER LIMITS THAT MAY APPLY TO YOUR PROPERTY TAX REVENUE, SUCH AS STATUTORY MILL LEVY CAPS, VOTER-APPROVED LIMITATIONS, THE TABOR PROPERTY TAX REVENUE LIMIT, OR THE TABOR PROHIBITION AGAINST INCREASING THE MILL LEVY WITHOUT VOTER AUTHORIZATION. THE PROPERTY TAX LIMITATIONS WORKSHEET (FORM DLG-53A) MAY BE USED TO PERFORM SOME OF THESE CALCULATIONS FOR COMPARISON TO THE "5.5%" LIMIT.

**The formula to calculate a Mill Levy is:**

Mill Levy =  $\frac{\text{Revenue}}{\text{Current Year's Net Total Taxable Assessed Valuation}^2} \times 1,000$

<sup>2</sup> Use the Net Total Taxable Valuation as provided on line 4 of the final Certification of Valuation from the County Assessor.

<sup>3</sup> Rounding the mill levy up may result in revenues exceeding allowed revenue.
