**A1. Adjust the 2018 5.5% Revenue Limit to correct the revenue base, if necessary:**

**A2. Calculate the 2018 Tax Rate, based on the adjusted tax base:**

Adjusted 2018 Revenue Base **[\$296,725]** ÷ 2018 Net Assessed Value **[\$8,475,210,160]**

= A2. **0.000035**

**A3. Total the assessed value of all the 2019 "growth" properties:**

Annexation or Inclusion **[\$0]** + New Construction **[\$189,426,660]** + Increased Production of Producing Mine **[\$0]**<sup>1</sup> + Previously Exempt Federal Property **[\$0]**<sup>1</sup> + New Primary Oil & Gas Production **[\$0]**<sup>1</sup>

= A3. **\$189,426,660**

**A4. Calculate the revenue that the "growth" properties would have generated in 2018:**

Line A3 **[\$189,426,660]** x Line A2 **[0.000035]**

= A4. **\$6,630**

**A5. Expand the Revenue Base by "revenue" from "growth" properties:**

Line A1 **[\$296,725]** + Line A4 **[\$6,630]**

= A5. **\$303,355**

**A6. Increase the Expanded Revenue Base by allowable amounts:**

A6a. The greater of 5.5% of Line A5 **[\$16,685]** or \$0 = **\$16,685**

A6b. Line A5 **[\$303,355]** + Line A6a **[\$16,685]** + DLG Approved Revenue Increase **[\$0]** + Voter Approved Revenue Increase **[\$0]**

= A6. **\$320,039**

**A7. 2019 Revenue Limit:**

Line A6 **[\$320,039]** - 2019 Omitted Property Revenue **[\$50]**

= A7. **\$319,989**

**A8. Adjust 2019 Revenue Limit by amount levied over the limit in 2018:**

Line A7 **[\$319,989]** - 2018 Amount Over Limit **[\$0]**

= A8.\* **\$319,989**

\* THE ALLOWED REVENUE OF A8 DOES NOT TAKE INTO ACCOUNT ANY OTHER LIMITS THAT MAY APPLY TO YOUR PROPERTY TAX REVENUE, SUCH AS STATUTORY MILL LEVY CAPS, VOTER-APPROVED LIMITATIONS, THE TABOR PROPERTY TAX REVENUE LIMIT, OR THE TABOR PROHIBITION AGAINST INCREASING THE MILL LEVY WITHOUT VOTER AUTHORIZATION. THE PROPERTY TAX LIMITATIONS WORKSHEET (FORM DLG-53A) MAY BE USED TO PERFORM SOME OF THESE CALCULATIONS FOR COMPARISON TO THE "5.5%" LIMIT.

**The formula to calculate a Mill Levy is:**

Mill Levy =  $\frac{\text{Revenue}}{\text{Current Year's Net Total Taxable Assessed Valuation}^2} \times 1,000$

<sup>2</sup> Use the Net Total Taxable Valuation as provided on line 4 of the final Certification of Valuation from the County Assessor.

<sup>3</sup> Rounding the mill levy up may result in revenues exceeding allowed revenue.
