**A1. Adjust the 2018 5.5% Revenue Limit to correct the revenue base, if necessary:**

A1a. The 2018 Revenue Limit **[\$1,339,028]** + 2017 Amount Over Limit **[\$0]** = **\$1,339,028**

A1b. The lesser of Line A1a **[\$1,339,028]** or the 2018 Certified Gross General Operating Revenue **[\$1,266,901]**

A1c. Line A1b **[\$1,266,901]** + 2018 Omitted Revenue, if any **[\$297]**

= A1. **\$1,267,198**

**A2. Calculate the 2018 Tax Rate, based on the adjusted tax base:**

Adjusted 2018 Revenue Base **[\$1,267,198]** ÷ 2018 Net Assessed Value **[\$213,354,890]**

= A2. **0.005939**

**A3. Total the assessed value of all the 2019 "growth" properties:**

Annexation or Inclusion **[\$0]** + New Construction **[\$1,347,650]** + Increased Production of Producing Mine **[\$0]**<sup>1</sup> + Previously Exempt Federal Property **[\$0]**<sup>1</sup> + New Primary Oil & Gas Production **[\$0]**<sup>1</sup>

= A3. **\$1,347,650**

**A4. Calculate the revenue that the "growth" properties would have generated in 2018:**

Line A3 **[\$1,347,650]** x Line A2 **[0.005939]**

= A4. **\$8,004**

**A5. Expand the Revenue Base by "revenue" from "growth" properties:**

Line A1 **[\$1,267,198]** + Line A4 **[\$8,004]**

= A5. **\$1,275,202**

**A6. Increase the Expanded Revenue Base by allowable amounts:**

A6a. The greater of 5.5% of Line A5 **[\$70,136]** or \$0 = **\$70,136**

A6b. Line A5 **[\$1,275,202]** + Line A6a **[\$70,136]** + DLG Approved Revenue Increase **[\$0]** + Voter Approved Revenue Increase **[\$0]**

= A6. **\$1,345,338**

**A7. 2019 Revenue Limit:**

Line A6 **[\$1,345,338]** - 2019 Omitted Property Revenue **[\$0]**

= A7. **\$1,345,338**

**A8. Adjust 2019 Revenue Limit by amount levied over the limit in 2018:**

Line A7 **[\$1,345,338]** - 2018 Amount Over Limit **[\$0]**

= A8.\* **\$1,345,338**

\* THE ALLOWED REVENUE OF A8 DOES NOT TAKE INTO ACCOUNT ANY OTHER LIMITS THAT MAY APPLY TO YOUR PROPERTY TAX REVENUE, SUCH AS STATUTORY MILL LEVY CAPS, VOTER-APPROVED LIMITATIONS, THE TABOR PROPERTY TAX REVENUE LIMIT, OR THE TABOR PROHIBITION AGAINST INCREASING THE MILL LEVY WITHOUT VOTER AUTHORIZATION. THE PROPERTY TAX LIMITATIONS WORKSHEET (FORM DLG-53A) MAY BE USED TO PERFORM SOME OF THESE CALCULATIONS FOR COMPARISON TO THE "5.5%" LIMIT.

**The formula to calculate a Mill Levy is:**

Mill Levy =  $\frac{\text{Revenue}}{\text{Current Year's Net Total Taxable Assessed Valuation}^2} \times 1,000$

<sup>2</sup> Use the Net Total Taxable Valuation as provided on line 4 of the final Certification of Valuation from the County Assessor.

<sup>3</sup> Rounding the mill levy up may result in revenues exceeding allowed revenue.
