**A1. Adjust the 2019 5.5% Revenue Limit to correct the revenue base, if necessary:**

A1a. The 2019 Revenue Limit **[\$10,353,216]** + 2018 Amount Over Limit **[\$0]** = **\$10,353,216**

A1b. The lesser of Line A1a **[\$10,353,216]** or the 2019 Certified Gross General Operating Revenue **[\$8,090,794]**

A1c. Line A1b **[\$8,090,794]** + 2019 Omitted Revenue, if any **[\$1,699]**

= A1. **\$8,092,493**

**A2. Calculate the 2019 Tax Rate, based on the adjusted tax base:**

Adjusted 2019 Revenue Base **[\$8,092,493]** ÷ 2019 Net Assessed Value **[\$170,332,511]**

= A2. **0.047510**

**A3. Total the assessed value of all the 2020 "growth" properties:**

Annexation or Inclusion **[\$0]** + New Construction **[\$4,277,006]** + Increased Production of Producing Mine **[\$0]**<sup>1</sup> + Previously Exempt Federal Property **[\$0]**<sup>1</sup> + New Primary Oil & Gas Production **[\$0]**<sup>1</sup>

= A3. **\$4,277,006**

**A4. Calculate the revenue that the "growth" properties would have generated in 2019:**

Line A3 **[\$4,277,006]** x Line A2 **[0.047510]**

= A4. **\$203,201**

**A5. Expand the Revenue Base by "revenue" from "growth" properties:**

Line A1 **[\$8,092,493]** + Line A4 **[\$203,201]**

= A5. **\$8,295,694**

**A6. Increase the Expanded Revenue Base by allowable amounts:**

A6a. The greater of 5.5% of Line A5 **[\$456,263]** or \$0 = **\$456,263**

A6b. Line A5 **[\$8,295,694]** + Line A6a **[\$456,263]** + DLG Approved Revenue Increase **[\$0]** + Voter Approved Revenue Increase **[\$0]**

= A6. **\$8,751,957**

**A7. 2020 Revenue Limit:**

Line A6 **[\$8,751,957]** - 2020 Omitted Property Revenue **[\$0]**

= A7. **\$8,751,957**

**A8. Adjust 2020 Revenue Limit by amount levied over the limit in 2019:**

Line A7 **[\$8,751,957]** - 2019 Amount Over Limit **[\$0]**

= A8.\* **\$8,751,957**

\* THE ALLOWED REVENUE OF A8 DOES NOT TAKE INTO ACCOUNT ANY OTHER LIMITS THAT MAY APPLY TO YOUR PROPERTY TAX REVENUE, SUCH AS STATUTORY MILL LEVY CAPS, VOTER-APPROVED LIMITATIONS, THE TABOR PROPERTY TAX REVENUE LIMIT, OR THE TABOR PROHIBITION AGAINST INCREASING THE MILL LEVY WITHOUT VOTER AUTHORIZATION. THE PROPERTY TAX LIMITATIONS WORKSHEET (FORM DLG-53A) MAY BE USED TO PERFORM SOME OF THESE CALCULATIONS FOR COMPARISON TO THE "5.5%" LIMIT.

**The formula to calculate a Mill Levy is:**

Mill Levy =  $\frac{\text{Revenue}}{\text{Current Year's Net Total Taxable Assessed Valuation}^2} \times 1,000$

<sup>2</sup> Use the Net Total Taxable Valuation as provided on line 4 of the final Certification of Valuation from the County Assessor.

<sup>3</sup> Rounding the mill levy up may result in revenues exceeding allowed revenue.
