The following steps were used to calculate your limit. The Division of Local Government encourages you to check each figure for accuracy. Years referenced are "Tax Year", *not* budget years. Amounts are rounded to whole dollars.

**A1. Adjust the 2019 5.5% Revenue Limit to correct the revenue base, if necessary:**

A1a. The 2019 Revenue Limit [\$42,345] + 2018 Amount Over Limit [\$0] = \$42,345

A1b. The lesser of Line A1a [\$42,345] or the 2019 Certified Gross General Operating Revenue [\$41,708]

A1c. Line A1b [\$41,708] + 2019 Omitted Revenue, if any [\$70]

= A1.

**A2. Calculate the 2019 Tax Rate, based on the adjusted tax base:**

Adjusted 2019 Revenue Base [\$41,778] ÷ 2019 Net Assessed Value [\$1,070,088,340]

= A2.

**A3. Total the assessed value of all the 2020 "growth" properties:**

Annexation or Inclusion [\$0] + New Construction [\$5,102,150] + Increased Production of Producing Mine [\$0]<sup>1</sup> + Previously Exempt Federal Property [\$0]<sup>1</sup> + New Primary Oil & Gas Production [\$0]<sup>1</sup>

= A3.

**A4. Calculate the revenue that the "growth" properties would have generated in 2019:**

Line A3 [\$5,102,150] x Line A2 [0.000039]

= A4.

**A5. Expand the Revenue Base by "revenue" from "growth" properties:**

Line A1 [\$41,778] + Line A4 [\$199]

= A5.

**A6. Increase the Expanded Revenue Base by allowable amounts:**

A6a. The greater of 5.5% of Line A5 [\$2,309] or \$0 = \$2,309

A6b. Line A5 [\$41,977] + Line A6a [\$2,309] + DLG Approved Revenue Increase [\$0] + Voter Approved Revenue Increase [\$0]

= A6.

**A7. 2020 Revenue Limit:**

Line A6 [\$44,286] - 2020 Omitted Property Revenue [\$68]

= A7.

**A8. Adjust 2020 Revenue Limit by amount levied over the limit in 2019:**

Line A7 [\$44,218] - 2019 Amount Over Limit [\$0]

= A8.\*

\* THE ALLOWED REVENUE OF A8 DOES NOT TAKE INTO ACCOUNT ANY OTHER LIMITS THAT MAY APPLY TO YOUR PROPERTY TAX REVENUE, SUCH AS STATUTORY MILL LEVY CAPS, VOTER-APPROVED LIMITATIONS, THE TABOR PROPERTY TAX REVENUE LIMIT, OR THE TABOR PROHIBITION AGAINST INCREASING THE MILL LEVY WITHOUT VOTER AUTHORIZATION. THE PROPERTY TAX LIMITATIONS WORKSHEET (FORM DLG-53A) MAY BE USED TO PERFORM SOME OF THESE CALCULATIONS FOR COMPARISON TO THE "5.5%" LIMIT.

**The formula to calculate a Mill Levy is:**

Mill Levy =  $\frac{\text{Revenue}}{\text{Current Year's Net Total Taxable Assessed Valuation}^2} \times 1,000$

<sup>2</sup> Use the Net Total Taxable Valuation as provided on line 4 of the final Certification of Valuation from the County Assessor.

<sup>3</sup> Rounding the mill levy up may result in revenues exceeding allowed revenue.
